CHARGE 1

*The Executive Committee of the College of Physicians and Surgeons directs that, pursuant to section 47.6 of **The Medical Profession Act, 1981**, the Discipline Committee hear the following charge against Dr. Kristyn Insley, namely:*

You Dr. Kristyn Insley are guilty of unbecoming, improper, unprofessional, or discreditable conduct contrary to the provisions of Section 46(o) and/or (p) of The Medical Profession Act, 1981 s.s. 1980- 81 c. M-10.1 and/or bylaw 7.1 particulars of which are that you provided inaccurate information to the College of Physicians and Surgeons of Saskatchewan in connection with your applications to renew your licence.

The evidence that will be led in support of this charge will include one or more of the following:

1. In approximately October 2014 you completed the application form to renew your licence.
2. You answered "no" to a question which asked whether you had been arrested or charged with a criminal offence within the past two years.
3. That statement was untrue.
4. In approximately October 2015 you completed the application form to renew your licence.
5. You answered "no" to a question which asked whether you had been arrested or charged with a criminal offence within the past two years.
6. That statement was untrue.
7. In approximately October 2016 you completed the application form to renew your licence.
8. You answered "no" to a question which asked whether you had been convicted of any criminal offence.
9. That statement was untrue.
7. In approximately October 2017 you completed the application form to renew your licence.

CHARGE 2

*The Executive Committee of the College of Physicians and Surgeons directs that, pursuant to section 47.6 of **The Medical Profession Act, 1981**, the Discipline Committee hear the following charge against Dr. Kristyn Insley, namely:*

You Dr Kristyn Insley are guilty of unbecoming, improper, unprofessional, or discreditable conduct contrary to the provisions of section 46(o)) of The Medical Profession Act, 1981 s.s. 1980- 81 c. M-10.1.

The evidence that will be led in support of this charge will include one or more of the following:

1. On or about June 25, 2014 you drove a vehicle while impaired by alcohol.

4. On or about June 25, 2014 you wilfully failed to provide a breath sample suitable for analysis.
